## Carry Concealed Weapon Permit continued...

**Finger Printing:** All new applicants are required to submit their fingerprints, via "Live Scan," to the Department of Justice for official clearance. You will need to make an appointment with the Records staff for fingerprinting. You may do so when you turn in your application. You will be notified at that time of your appointment date for finger printing.

Notification of Confidentiality: Applicant's information which is contained in the application for the CCW permit may be subject to public access under the Public Records Act. Government Code 6254 (u)(1).

**Note:** Turlock Police Department recognizes your desire to be responsible and obedient of the law. Please be assured that your application will be thoroughly investigated and a decision to grant or deny the permit will be based upon state law and the information provided and learned during the investigation. **Fees** (these amounts are subject to change as permitted by law)

#### New Applicants

Department of Justice Fee: \$93 (as of 3/19/14 and subject to change as stipulated by law)

Fingerprinting Fee: \$10

Turlock Police Department Permit Processing Fee: \$100 {20% - (\$20) due at submission of application}. The remainder of the fee balance (\$80) shall be paid if CCW approved and at time of issuance of CCW License.

Department of Justice Fee: \$52 (Check/Money Order made payable to DOJ)

<u>Turlock Police Department Processing Fee</u>: \$25 (Check/Money Order made payable to City of Turlock)

# **Turlock Police Department**

Thank you for your interest in a "Carry Concealed Weapon" (CCW) permit. The attached application meets the requirements as set forth by the California Department of Justice (DOJ).

It is the intent of Turlock Police Department to strictly adhere to the rules outlined by the Department of Justice and Penal Code §§ 26150 through 26155. Those rules are carefully outlined on page 1 of the application packet.

<u>All new and renewing applicants must</u> <u>submit a "CCW" Department of Justice</u> <u>Application</u> which is available at the Turlock Police Department or on our web page. Please thoroughly read and complete the application as indicated. <u>Illegible, incomplete, willful omissions or</u> <u>untruthfulness will cause your application</u> to be rejected and or denied.

A voluntary application review is available to you by appointment through the Office of Professional Standards prior to submitting the application and paying fees. If you have any questions please contact the Office of Professional Standards at (209) 664-7345. The following are the requirements as stipulated in Penal Code §26150-26155:

**Residency:** You must be a resident of the City of Turlock and show proof of such; i.e. Utility Billing, subscriptions, etc. These must be no older than 30 days. Post Office Box addresses are not residences and will not be accepted. A valid California Identification Card or Drivers License must also be presented. Proof of ownership of any weapon to be licensed must be provided. All applicants must be at least 21 years of age or older.

**Good Moral Character:** You must be of "Good Moral Character"; that being a law abiding citizen, honest, respect for the rights of others and for the laws of the state and nation and free from drug and or alcohol addiction.

No disqualifying law violations or convictions, no dishonorable discharge from military.

The Turlock Police Department's responsibility for public safety dictates that good moral character be established prior to the Chief of Police issuing a CCW permit.

This information will be obtained from the applicant during the CCW interview process.

You will be notified of the status of your application and will be advised to proceed with the required training, if your CCW is approved by the Chief of Police, pursuant to Penal Code 26155. If a determination of "good moral character" does not exist, you will be advised and that your application has been denied.

**Training:** You must complete required training as stipulated in the Penal Code §26155 and the course must be acceptable to the Turlock Police Department. Additionally, the training required <u>must be supported by an approved certificate of completion</u>. New applicants must complete a course which meets the requirements outlined in Penal Code §§26165(a). Renewal applicants must complete a course which meets the requirements the requirements of Penal Code §26165(c). The training must be completed prior to issuance of CCW permit.

A current list of acceptable course providers is attached and also available on-line or on our web page. (If you have a course that you would like added to our list please submit all course documentation, curriculum and instructor certification to Office of Professional Standards for consideration).

In the event civil or criminal litigation is pursued against the CCW holder, the Turlock Police Department encourages those individuals who have been issued a CCW to obtain and maintain CCW insurance.
