#### SUPERVISOR COMMENTS

It was a busy night for swing shift and graves with in-progress calls. Officers responded to an assault & battery in progress at a gas station parking lot. The victim of the battery started to run away and was approached by an unknown male who offered to help her get away. The male grabbed the victim and put her in the passenger seat of his truck. The victim told the male she did not want to go with him, as he began to drive away with her. The male then got out of the truck and went around to the passenger side where he began to grope the female under her clothes and kiss her. The victim was able to push the male away and run. It just so happened that two officers were nearby on a traffic stop when the victim saw the police lights. She ran to the officers hysterical and screaming. She had injuries from the assault and battery and injuries from the attempted kidnaping, both incidents were unrelated, and appears the male was taking advantage of the situation the victim was in. The suspect is unknown at this time and there were no witnesses located.
