SUPERVISOR COMMENTS

An officer was extra patrolling the parking lot of a motel when he on-viewed a physical fight between a male and female. The officer intervened and during the investigation determined that a domestic battery had occurred. After arresting the male, a search was done and officers located narcotics in his pocket. Additionally, the male was on probation and found to be in possession of several different types of burglary tools. The male was booked into jail on several charges, including a violation of probation. An officer contacted three people who were standing outside of a closed business looking into the windows. One of the subjects lied about their name and the true identity was eventually discovered. She had a felony warrant and was placed under arrest. She was also charged with giving a false name and trespassing, due to a trespass letter being on file with the police department; She was booked into jail.
