# SUPERVISOR COMMENTS

Today was a very busy day for the dayshift officers. Early in the morning, right after briefing they responded to a report of a subject who was in another's backyard and was hitting his head against the backdoor. The officers arrived and quickly detained the subject. It was determined he was having a mental health emergency and was placed on a mental health hold. Later in the day officers responded to what initially sounded like a juvenile out of control. They discovered that the 15-yr. old juvenile was terrorizing his family and attempted to strike several of them with a hammer. He was arrested for a felony and taken to juvenile hall. Also, during the shift, TPD dispatch received a call from a subject who has a history of calling 911 without a valid reason. This subject was arrested several times for doing this, with the most recent being last week. After he called today and tied up a dispatcher, he was located and contacted. He was arrested again for mis-use of the 911 system.
