SUPERVISOR COMMENTS

It was a steady call volume for graveyard officers. In-progress calls were still coming in at the time of this log. Earlier in the night an officer made a traffic stop and contacted the male driver who was determined to have an active I&B for his arrest on identity theft related charges and burglary. After the arrest a search revealed several credit/debit cards and other person identifying information belonging to several people. A search of the vehicle revealed narcotic pills, loaded syringes, and other drug paraphernalia. As the officers on scene were trying to place the male into the unit for the transport to the jail he began to scream and hit his head against the inside of the patrol car. A WRAP device was used in order to transport him safely to the jail where he was booked for the I&B and other charges. Officers also had an encounter with a female who was under the influence of a narcotic and was causing a hazard in the roadway. She had almost ridden a bicycle into one of the officer's patrol vehicle and was dancing in the middle of the roadway. She was arrested and booked for public intoxication, as she obviously could not care for her own safety.
