Our last day of our work week proved to be another busy one. Officers were able to respond to the calls for service, and some were able to make a few traffic stops as well. Officers followed up on a previous call of vandalism in which flour was poured into the gas tank of an ex-girlfriend's vehicle. Through the follow-up, officers confirmed the identity of the suspect, as well as uncovered evidence of stalking. The subject was located and arrested for the crimes. Officers then responded to a disturbance at a residence. The caller wanted to remain anonymous, and stated that there was a subject who was publicly intoxicated from the use of nitrous gas. When officers arrived, the subject was actively ingesting the gas, and he should obvious signs of being intoxicated. He refused orders by the officers to stop, as he stated that since he was on his private property, the police could not arrest him. He was subsequently detained, and found to have prescription pills on his possession. He also had a felony warrant. He was taken to jail.

He was arrested/booked for felony DUI, felony hit and run, felony child endangerment, and a felony warrant out of San Joaquin County.
