BROWN GOT YOU DOWN? HOW ABOUT SOME H20 TO GO?

Could your lawn and garden use a little help to stay green? The City of Turlock has opened a recycled water filling station to provide free recycled water for local residents to water lawns, gardens and landscaped areas, as well as for limited commercial use. Turlock's recycled water had gone through extensive treatment and is now available for free for authorized residential users and at a nominal fee for commercial users. The fill station is a self-serve drive through system located at the Turlock Regional Water Quality Control Facility at 901 S. Walnut Road, and is open Monday-Friday from 8:00am to 3:00 p.m. Those interested in utilizing recycled water must first complete an online certification program. Upon completion of the online course, customers must submit a certificate of completion and a completed application to the City of Turlock Municipal Services Department at 156 S. Broadway, Ste. 270, Turlock. The certification program ensures that customers understand state regulations related to recycled water, such as: proper uses of recycled water, procedures for collection and transportation, restricted uses and other pertinent information. Approved applicants will receive an identification card and appropriate labels for their user supplied recycled water containers. The application for recycled water use can be

downloaded from the City of Turlock website at **www.CityofTurlock.org**, or by picking up a

Many California Businesses and Multifamily Complexes Now Required to Recycle Organic Waste

The State of California recently enacted AB 1826, which requires businesses and multifamily residences that generate specified amounts of waste to arrange for recycling services for organic waste by April 1st, 2016. Organic material, as defined by the State. includes: food waste, green waste, landscape and pruning waste, nonhazardous



wood waste. and foodsoiled paper. Gardening or landscaping service

offered to those businesses in the above categories are also subject to this law and businesses must ensure that this organic waste is recycled. Multifamily residences are only required to arrange for recycling services for green waste. The City of Turlock and Turlock Scavenger Company have services available to assist businesses and multifamily residences to be fully compliant. For commercial businesses who do not currently subscribe to organic (garden) refuse disposal service, but meet the threshold for service requirement, contact Turlock Scavenger Company immediately at (209) 668-7274 to arrange for organic recycling service.

The City's previous garden refuse collection service, which is collected in the residential green cart, is now the City's organic collection service and should be utilized for disposal of garden refuse and organic material.
