City of Turlock Has levels of 1,2,3-TCP Above Drinking Water Standards

Our water system recently failed a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what you should do, what happened, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Testing results we received in October 2024 show our system exceeds the standard, or maximum contaminant level (MCL), for 1,2,3-trichloropropane (1,2,3-TCP). The standard for 1,2,3-TCP is 0.005 ug/L (micrograms per liter) equivalent to 0.000005 mg/L (milligrams per liter). The average level of 1,2,3-TCP for the period of October 2023 – September 2024 for four out of the eighteen drinking water wells was 0.005 ug/L, ranging from 0.000 ug/L to 0.014 ug/L.

What should I do?

- **You do not need to use an alternative (e.g. bottled) water supply.**
- This is not an immediate risk. If it had been, you would have been notified immediately. However, *some people who drink water containing 1,2,3-trichloropropane in excess of the MCL over many years may have an increased risk of getting cancer.*
- If you have other health issues concerning the consumption of this water, you may wish to consult your doctor.

What happened? What was done?

On December 14, 2017 the State Water Resources Control Board's Division of Drinking Water established a MCL and monitoring frequencies for 1,2,3-TCP that went into effect January 2018. Due to the newly adopted MCL, the City of Turlock has three wells that have exceeded the allowable limits for the contaminant.

The City rehabilitated a well which consistently samples non-detection for 123 TCP since February 2023. The City also permitted two new water source(s), the Stanislaus Regional Water Authority on October 2023 and a well with 1,2,3-TCP treatment on May 2024. The introduction of the two new source(s) helped inactivate two wells (over the 1,2,3 TCP MCL). The City also turned off two wells from adding water to the system, one on November 2023 and another on September 2024. The City is operating just one (1) well with detection(s) above the allowable limits.

The City is required to continue increase monitoring frequencies for 1,2,3-TCP, developed a corrective action plan, and distribute public notices to all drinking water customers every three months until the wells are no longer producing levels of 1,2,3-TCP above the MCL.

The City is working with the State to be in compliance.

You can do this by posting this public notice in a public place or distributing copies by hand or mail.

Secondary Notification Requirements

Upon receipt of notification from a person operating a public water system, the following notification must be given within 10 days [Health and Safety Code Section 116450(g)]:

- **SCHOOLS:** Must notify school employees, students, and parents (if the students are minors).
- **RESIDENTIAL RENTAL PROPERTY OWNERS OR MANAGERS** (including nursing homes and care facilities): Must notify tenants.
- **BUSINESS PROPERTY OWNERS, MANAGERS, OR OPERATORS:** Must notify employees of businesses located on the property.

This notice is being sent to you by the City of Turlock in compliance with the California Domestic Water Quality and Monitoring Regulations as a means of keeping the public informed.
